PRESIDENT'S REPORT 2003 – 2004

As President of the Sydney Shires Cricket Umpires Association (SSCUA) it is my pleasure to commend to you this SSCUA 2003/04 Annual Report.

I also have the opportunity to reflect on the progress of our Association and most importantly – ruminate on what I see as the Association's most pressing future challenges.

In turning to reflect on Season 2003/04 I think it has been one of both consolidation and growth for the SSCUA.

Consolidation of the Association took place from the perspective that as the season progressed (and indeed as future seasons unfold) our members have continued to build upon and enhance their umpiring technique, knowledge of the Laws and man management skills. This is particularly relevant when one considers that most of our members, at the present time, have three (3) years or less experience and are by our own admission - still travelling up a very steep learning curve. The really positive outcome is that we are already producing some excellent umpires, who if they maintain their passion and commitment to the game, could well progress to higher-grade honours.

In terms of growth, the SSCUA, after a concerted advertising drive, increased its membership considerably from the end of season 2002/03 to a total of 43 by Christmas 2003. With our ranks bolstered on occasions by our umpiring colleagues from the Grade panels, the SSCUA has been able to appoint two umpires at every 1st grade game in every game of the season and on occasions, have one or two umpires officiating at games down to third grade. A position which we would never have dreamed of when only four of us turned up to the Briars Club in 2000 to discuss the formation of the SSCUA!

The challenges that lie ahead for the SSCUA are probably many and varied. In no particular order of importance my personal selections of some of the major issues are:

1. Attracting new members to, and retaining existing members within, the SSCUA
2. Developing the capability to appoint umpires to as many games as possible across all Shire's grades;
3. Ensuring that the SSCUA has in place a disciplined framework and operating structure;
4. Growing, developing and consolidating the SSCUA's individual identity as a progressive and vibrant entity - albeit under the umbrella of the NSWCU&SA – within the SCA generally and the Shires Competition specifically;
5. Ensuring that the SSCUA's service and performance strategies and objectives are clearly aligned to the service needs all of its stakeholders;
6. Continuing to operate in an open and responsive manner – particularly in the engagement and involvement of its members.

In closing this season's President's Report I'd like to reiterate my sincere thanks to all those who have supported and assisted the Association over season 2003/04. We look forward now to a rest over winter and coming back bigger and better in 2004/05.

It is my pleasure to present this my third Secretaries Report for the Sydney Shires Cricket Umpires Association.

As the start of the season approached the pre season numbers of members indicating full time on field availability looked rather grim. I was half convinced we were going to have a similar season to 2002-03 where the numbers of on field members was barely adequate to cover the compliment of first grade games each week.

To combat this your committee went on an aggressive advertising campaign sending out information about our Association to every single local newspaper in the Sydney metropolitan area. I'd like to thank the approximate 75% of those local newspapers who ran stories about us. The net result was about a dozen enquiries from people who wanted to become umpires or those wishing to resume an umpiring career from the past.

In light of this response we set up a special Shires training course. I cannot speak highly enough of the assistance that was offered to us by Peter Hughes , Laurie Borg , David Dilley and Graham Chudleigh from the NSWCU&SA who agreed to run this course for us. The course and examination were completed by the end of the seasons second match. The net result was an extra six bodies who came on board with us as full time umpires. Not a lot in the big scheme of things but more than enough to get our second grade competition umpires in about three or four of its seven matches each round. This was a marked improvement on the previous season.

A warm welcome to the following gentlemen who joined us as new members this season and who came through the above mentioned training course.

Peter Garlick - Answered our add for umpires and came to us with extensive experience umpiring in schools competitions. Received many compliments about his umpiring and we hope Peter has a long and fruitful career with us in the Shires competition.

Spencer Harrison - Spencer hadn't umpired for quite a number of years and had previously spent time in the local Parramatta competition in the past. Received a lot of good marks and handled himself very well to all accounts.

Warren Knowles - Warren had recently moved to Sydney from Melbourne. He had previously umpired some "park" cricket in Victoria. He did two and a half games with us and then mysteriously vanished. All future efforts to contact Warren were unsuccessful. Put that one in the X Files Mr Mulder !

Brett Osseweyer - Brett was our “junior” applicant aged in his early 20’s. He decided to give cricket umpiring a crack and did a great job in his first year. Brett has a bright career ahead of him whether it be in Shires or Grade.

Trevor Schokman - Trevor passed the exam and then joined us only a few years after the end of his playing career. Trevor is an ex Lindfield player who I must say I always had a great battle with in the matches I played against him. Acquitted himself very well in his first season as an umpire.

Chris Taylor - Chris was our Pommy connection. He umpires in England and was in Sydney for an Aussie Summer where he received a lot of praise for his on field umpiring. It was a pleasure to have Chris on board and hope he visits us again next Summer.

We also had the following new members join our ranks during the season from various backgrounds –

Jeff McKinnon – Joined us after 2 seasons on the sideline having umpired in Grade Cricket in Panels 3 & 4 in 2001-02. Due to work commitments had to withdraw from his Grand Final appointment which must have been disappointing for him. We hope to see Jeff back next year for another successful summer.

Alan Green – Joined us at the beginning of Round 6 after umpiring First Grade last season. Alan brought a wealth of experience to Shires having over 200 grade games under his belt a lot of them being First Grade. It would be a pleasure having Alan back in Shires next year. Alan made to me a very interesting comment that he felt that Shires First Grade was like umpiring the Standard of Grade First Grade cricket with all the players on prozac ! Quite a compliment for the standard of play and particularly the behaviour in Shires Firsts !

Laurie Byrne – Joined us having completed and passed the mid winter training course. Due to work commitments only did 2 games this season. Hopefully Laurie can get in a few extra games next season.

Wes Scott - Wes passed the exam but is still playing club cricket on Saturdays. He was very keen to umpire on Sundays wherever possible. Ended up umpiring just about all of the Frank Gray games on Sundays and did quite well to all accounts

Stephen Murphy – Stephen umpired grade cricket in Panel 4 the previous season but joined us this year due to limited availability. Only ended up doing 2 games – Hopefully a few more next season !

Peter Tasker - Peter was a full time Panel 4 Grade umpire on Saturdays who wanted to join us for some Sunday games where possible. I was more than happy to allocate Peter some Frank Gray games and he would be more than welcome on the full Shires panel for Saturdays if ever he wants to make the move.

Luke Mulligan & Richard Christen – Two others similar to Peter Tasker. Luke & Richard both umpired Grade on Saturdays in Panel 4 but were keen to hold membership of our Association. Richard also a handful of Frank Gray games during the season when required.

All in all our total membership for the season was a credible 43 with 18 of these members umpiring more than 10 matches in the season. Another 18 members did less than 10 matches and 7 members held membership without actually taking the field this season. I can only hope that those who couldn't umpire this season have their circumstances change in 2004-05.

Another positive aspect to occur during the summer was the high percentage of people available to umpire Grade Cricket during the season. Whilst the flow down of surplus Grade umpires into the Shires competition didn't occur in October or November due to various reasons (eg World Cup Rugby , School Cricket being on , Lower than normal availability , etc etc) the fact was that by the time we got to December , January and to a lesser extent February Peter Hughes at the NSWCU&SA regularly had a couple of Panel 4 umpires surplus after his appointments were completed. In each case these umpires were allocated a Shires game as near as possible to their suburb of residence and in the majority of cases handled themselves quite well. We did have a few problems with a couple of Grade umpires officiating in a couple of Shires matches and between myself and Peter Hughes I think we were adequately able to communicate the clubs concerns onto those particular umpires.

The result of this overflow from Grade cricket was that Shires had a total of 17 Grade Umpires appointed to an extra 15 Shires matches that without this overflow would not have had umpires in the first place. That's a win – win scenario in anybodys language if you ask me !

I want to thank Peter Hughes at the NSWCU&SA for allowing us the use of his surplus numbers and I'm sure this arrangement can be expanded on in the future

Another up side with the relationship we had with Grade Cricket was the fact that Shires Members were offered the opportunity to umpire in the Green Shield Competition during the summer school holidays. As well as this we were allowed to umpire in Grade Cricket on January 3 when Grade played a limited overs round and Shires were having a week off.

I know that the nine guys who got a run in Grade Cricket on January 3 got an eye opening look into a different breed of cricket. Some liked it , others hated it. Each to their own I say. But the big plus about our guys umpiring Grade on this day was that Shires members for the second year in a row filled up a number of gaps in the Grade appointments that round that without our help would have seen a number of 5th Grade matches go without umpires ! Well done to all of you who put your hand up on January 3 when some regular grade umpires decided they had “other” things to do. Wasn't there a test match on at the SCG that day ?

In on field issues we started the season with an important change to playing conditions in standard two day games. The SCA ruled that play start at 1pm (instead of 12.30pm) and the number of overs in a day be reduced from 85 to 80. Using simple mathematics it was clear to everybody (seemingly except the SCA) that this was going to cause problems. We now had a situation where teams were being required to bowl at the ridiculous over rate of 17.2 overs per hour compared to the previous seasons 16.4 per hour which in itself was rarely achievable.

The net result of this decision was that the majority of matches were finishing way beyond the scheduled 6pm finishing time in daylight saving games. Umpires were regularly doing 30,40,50 even God forbid 60 minutes overtime simply because the asking over rate was unachievable. This current situation in my opinion is totally unacceptable and we will be lobbying the SCA through the Shires Sub Committee to go to a 12.45pm start leaving the required overs at its current daily quota of 80. This will reduce the asking over rate to 16.2 which is a much more sensible rate in this day and age.

This proposed changed will also ensure that the majority of matches will finish at 6pm on the dot and umpires and players alike can get home on a Saturday night at a time that wont cause a divorce in the home. I firmly believe if we can guarantee umpires that matches will finish at 6pm and not drag on and on into their Saturday evenings that we would have a better chance of picking up a few extra members. Getting home at 9pm is NOT fun !!

Another big initiative that started this season was the introduction of the Spirit Of Cricket Award. Umpires were required to allocate a mark from three down to negative one assessing each team on their “Spirit Of Cricket” ethics displayed in the game. In Shires matches with no umpires in lower grades the opposing captain marked his opposition. Whilst this award is a great one in theory my perception was that only a few clubs changed their on field behaviour this season and some clubs only brought up the “Spirit Of Cricket” subject when it suited them and the position of the match at any given time.

I personally viewed captains who took this stance dimly and a mark of zero was regularly allocated to teams that took this line of thinking. I encourage all members to adopt this stance in the new season as Spirit of Cricket should be displayed at all times and not just when it suits.

In a closely fought contest congratulations are extended to the Burwood Club for winning the overall inaugural Shires Spirit Of Cricket Club Of The Year. Burwood had an average Spirit Of Cricket Mark for its entire Club of 2.138 out of a maximum of three - Well done Burwood !!

Burwood were closely followed by Lindfield on 2.121 then Roseville on 2.054, Epping on 2.053 , Georges River on 2.000 and Southern Districts on 1.983. The SCA made the remaining eight clubs positions only known to each individual club in question which I personally found to be totally unproductive as it hides and shields the inadequacies of the clubs that showed poor spirit of cricket ethics in the season.

The teams that won the individual grade awards for Spirit Of Cricket were -

1st Grade - Roseville (2.385)

2nd Grade - Burwood (2.538)

3rd Grade - Georges River (2.385)

4th Grade - Southern Districts (2.000)

Frank Gray - Lindfield (3.000) - Perfect Score in all 6 matches played !!

On the subject of Spirit Of Cricket and player behaviour I need to report that we had a pretty average year for bad player behaviour. A total of six Shires players were reported to the SCA Code of Conduct Commissioner. Of this total of six I can advise that three of them were players reported by members of this Association with the other three reports being made by Clubs. Of the total of six reports made to the SCA four received a suspension, one received a caution and suspended sentence and one was dismissed – (The one that was dismissed was a club complaint and not from an umpire)

As well as the six reported players above I am also aware of at least FOUR incidents this season where members of this Association failed to report players for some rather appalling behaviour. To say I am disappointed in these members is an understatement. Members who allow this sort of “gutter” behaviour only allow the problem to fester onto one of your colleagues in future matches. We MUST take a harder stance on this sort of garbage occurring in Shires matches. The Code Of Conduct Commissioner fully supports umpires reports and cases are now being heard in a timely manner so there is now no excuse for ignoring bad behaviour.... EVER

Deciding not to report players for showing serious dissent or breaching the Spirit of Cricket conditions is just not acceptable. Taking the attitude of “Sweeping it under the carpet” or “I couldn’t be bothered” is in my opinion lazy and irresponsible. Reporting an incident doesn’t necessarily mean it’s a Judiciary matter. The decision if an incident is bad enough for a Judiciary hearing is the role of the Code of Conduct Commissioner. Your report may not make it to the Judiciary but it may make the difference if a future incident on the same player occurs as this shows a pattern of conduct by that player.

Its is my personal opinion that members who don’t do the right thing in the next season and elect to ignore any sort of poor player behaviour should be asked to justify their actions to the Executive of this Association.

During the season three of our members received appointments to representative matches. Bruce Parfett officiated in the Annual Shires XI Vs Grade XI match at the SCG. Peter Friend umpired the inaugural Shires XI Vs Churches XI match at Lindfield Oval whilst Gordon Smith received an appointment to a three day test match involving Australia Deaf v England Deaf at Uni of Sydney #1 Oval. The only twist here is that Gordon and his partner for the match Arthur Watson were the only two people on the field that could actually hear – but some might say that was debatable! A Report on each of these matches is covered elsewhere in this report.

The seasons major fund raising activity was the Sydney Cricket Association (SCA) raffle. This raffle is where the SCA puts up all the prizes and prints off all the raffle books. We thank the SCA for their ongoing support by making this raffle available to all clubs and Associations. The way it worked is that the SCA charges each participating Association or club \$2 for the printing of each raffle book supplied. Each book contains 20 raffle tickets to be sold at \$2 a pop with the entire proceeds of ticket sales to go to each of the participating Associations or clubs. This means that we earned a clear \$38 for each whole raffle book sold. At the start of the season your committee decided to purchase a total of 40 books at a cost to us of \$80. These books were distributed to all active members. I can report that the total amount we raised (deducting the initial \$80 outlay) was net \$1,160.00

I want to thank all the members who took on the shared responsibility of fund raising for this Association and sold a raffle book. I also want to thank the 2 or 3 members who didn't want to sell a book but contributed a \$40 donation instead. Finally though I'd like to express my extreme disappointment with a number of members who only partially sold a raffle book or worse still refused to sell a book and returned it unsold. Some members just didn't return the book at all ! These members (in my opinion) have let this Association down badly. All members share an equal burden to assist in fund raising for this Association. How hard can it be to sell 20 little raffle tickets to your family , friends or work mates ? Please guys , a bit more consideration next season as the proceeds of this raffle keeps your membership fee down at \$10 per year. Without this raffle a large hike in your annual membership fee might be on the cards. Maybe it might be easier to increase membership fees from \$10 to \$50 and any member who wants to offset their membership by \$40 can ask to sell a raffle book. An issue to be discussed at the AGM.

Moving back to on field matters I want to congratulate the competition winners this season as follows –

- 3rd Grade – Burwood**
- 4th Grade – South Sydney**

The finals series was played in fantastic weather until 7am on the morning of the second day of the Grand Final. At this point rain ruined what should have been a great day for everybody except for the second grade match which managed to get a result due to three hours of play in the afternoon. It seemed that everywhere in Sydney it was pouring except at the second grade match where the rain held off long enough to see the Warringah club pip the Minor Premiers Burwood. No play was possible at all in the 1st , 3rd and 4th grade finals on day two. It was such a shame to see grand finals won on a rained out draw but we simply don't have any control over the weather.

Congratulations are also extended to the Burwood club who had a great year taking out an extremely close win in the Club Championship as well as winning the Frank Gray Final and having three of their four sides participate in the Grand Finals. A super year all round from the Briars boys.

As you all know a “perfect score” from a captain is a mark of 12 out of 12 for a match obtaining a maximum mark of three in each of the four measured competencies.

Most umpires would have achieved a perfect score of 12 from a captain on more than one occasion during the season. Invariably a mark of 12 comes from a winning captain. I would now like to acknowledge the following umpires who achieved what I consider to be the “holy grail” of umpiring --- A Mark of 12 out of 12 from BOTH captains in the same match.

Appointed Umpires Report – Rep Fixtures 2003-2004 season

Sydney Grade XI vs. Sydney Shires XI Thursday 4th December 2003

In 2000, if anybody had suggested to me that in 2003 I would umpire a cricket match at the SCG - I would have told him or her they were dreaming. Yet, here I was, on Thursday 4 December, preparing to stand in the annual Sydney XI versus Shires XI representative cricket match, at one of the finest cricket grounds in the world. What a buzz!

Arriving at 8.15am for a 10 am start, I had recollections of the story about how Dickie Bird had arrived so early for his first test match that he contemplated climbing the locked gates to get in! Still better to be early rather than late! I could not even contemplate how I would've felt had I been late for this game!

As I gazed out over the empty ground I wondered to myself how the umpires might feel when this very same ground was full to capacity for an Australia vs England Ashes Test match - with all of its tradition and expectations and the accompanying colour and noise.

Yet here I was, looking out over this magnificent, albeit empty ground, with only a few workmen for company, feeling somewhat nervous about the challenge of what lay ahead. Certainly there would be no back page coverage of the game – but as far as I was concerned, this was my “test match”. I knew I wouldn't be back to stand on this ground again in any official capacity and I certainly didn't want to leave the ground at 6 o'clock having let my partner, the Shires Association or myself down. I was determined to represent the Shires Cricket Umpires Association to the best of my ability. Pressure – what pressure!!

Soon people started to arrive and I was extremely grateful to be welcomed by Ian Field, the SCA Secretary. I always find Ian to be an extremely calming sort of bloke and a short chat with him quelled the butterflies - at least for the moment anyway. Also helping to quell the intestinal juices was the sight of a few familiar faces of players from the Shires Clubs. Although balancing the familiarity of the Shires players was the total unfamiliarity of the Grade players!

My partner for the day, Margaret Beaumont, arrived shortly thereafter and I was glad to have the chance to meet her and chat about the day ahead. I was keen to draw on Margaret's 1st Grade experience and whilst I was more than happy to defer to her as “the senior partner”, Margaret soon made it quite clear that we were equal and she would have none of this seniority business!

Margaret made me feel at ease straight away, although I was thinking to myself that this “ease” would be tested in the sorting out of the change room protocols. I certainly didn't want to make a point of it but I was sure being equal in the partnership would not extend to the “sheds”!

On entering the umpires' change rooms, one couldn't help but be slightly overawed with the sense of history that seemed to ooze from the photographs of past and present Test and 1st Class umpires that adorned the walls. To think that the likes of

Dickie Bird, David Shepherd, Steve Bucknor and our own Darryl Hair and Simon Taufel had prepared for a test match in these very same rooms was a particularly humbling thought.

Having discretely sorted out our change room arrangements, Margaret and I eventually made our way down the timber stairs and into the Long Room (or is it merely the Members Bar?). With the customary "invitation" to both teams we were now on our way to the "middle". Sydney to bat – Shires to bowl.

On the way to the middle, I again made the mistake of referring to Margaret as the senior partner when offering her the choice of ends. Once again she reminded me that we were equal. Hopefully, this would be my last mistake for the day!

The ground from the Member's Pavilion is a terrific sight. From the middle - it is truly amazing. The feeling as I stood in position, under a blue sky, looking around the ground at the various stands would take someone of far better eloquence than me to adequately describe. Chuffed springs to mind.

It was evident, from the first ball of the Sydney innings that Shane Stanton, the Sydney captain and opening bat, was intent on getting on with the business. Equally, the Shires new ball bowlers - Paul Sullivan and Shaun Day - certainly did not look out of place in this company. Their line and length kept the aggressive Sydney batsmen in check and allowed early wickets to be picked up regularly and reasonably cheaply.

Unfortunately, the early in-roads into the Sydney batting line-up could not be capitalised on and with two of the younger middle order batsmen firing, Sydney went from 4/59 to 5/278 with some very punishing but controlled batting. At the end of their allotted 50 overs, Sydney had reached a commanding, but not unreachable, total of 6/325. Of this total, the number 5 bat, N. Hill, had retired hurt on 104, whilst the number 6 bat, D. Wallace was unlucky to fall five short of a well deserved century.

Best of the Shire's bowlers from their 10 overs were Paul Sullivan with 2/62 and Shaun Day with 2/56, with good support from Ian Rockwell taking 1/32 of his 5 overs.

Standing at square leg for the first over of the Shires innings, I was immediately impressed with the speed of Sydney's opening bowler, Kim Daley. This first impression was not lessened when Will Gell took the new ball from my end. I was even more impressed that both the Shires' opening bats had elected not to wear helmets! Judging by the comments of the Sydney fieldsmen – they too were impressed with the batsmen's cavalier approach – but probably not for the same reasons! Indeed their vocal support of their opening bowlers and my trepidation seemed to rise a couple of notches as the Shire's batsmen took a "Keith Stackpole" approach to anything short of a length.

Mark Oliver from Southern Districts was the first of the batsman to fall - just managing to top edge a ball from Daley back to the bowler. To say the batsman was a tad late in playing an attempted pull shot would not be an overstatement!

Whilst the Shires lost a second wicket quickly, Steve Moran from Macquarie Uni and Peter Crocker from the Lindfield club, combined to steady the ship in a solid performance which saw 66 added for the third wicket.

It wasn't until the score had reached 78 that Steve, wearing a terrific black eye from a mid week training mishap, was finally dismissed for a gritty 52. He had played extremely well at the top of the order and mixed stoic defence with good aggression in ensuring that the Sydney bowlers didn't have things all their own way.

Murray Rayner, from the South Sydney club, joined Peter at the crease and the ex-Gordon pairing, under increasingly threatening skies, set about consolidating the innings. Murray looked particularly impressive. He was solid, confident and fluent in his stroke making. Peter, at the other end, was undertaking the archetypal supportive sheet-anchor role - a role he was playing with real g & d.

But at 3/120 and after 26 overs, all this promise was to come to nought as the SCG ground staff, aided by what turned out to be extremely accurate weather forecasting, appeared from nowhere, at the top of the bowlers run at my end, to call a halt to proceedings. Their intervention was extremely fortuitous because no sooner had we left the ground than down came torrential rain supported by a very impressive thunder and lightning show.

Who knows how the game may have ended up, but it would have been interesting to see just how far the Shire's batting line-up would have gone in chasing down the Sydney score. With Murray and Peter well settled on 28 and 33 respectively, we might well have seen a terrific game of cricket develop, one where invariably the Shires start as the underdog.

Declared a draw at just after 4pm, and despite the premature and disappointing finish to the game, I'm sure that players from both sides thoroughly enjoyed their SCG experience. Judging by the camaraderie in the Shires XI dressing room after the game, I'm also sure that the Shire's players enjoyed the opportunity of playing together in a representative side.

From my perspective, I enjoyed the experience immensely. I'll never forget the sense of occasion I felt in walking on to the SCG to take up my position at the start of the game. Nor will I forget the quite unique sound of a clean strike of bat on ball as it reverberated around the ground. I will be forever grateful to the SCA and the Shires Cricket Umpires Association for their nomination and the opportunity of standing in the game. It was a pleasure to umpire both teams and my thanks go to the respective captains Shane Stanton and Murray Rayner for ensuring that the game was played in a professional and sportsman-like manner.

To Ian Field and his team on the day – a very big thank you. To Stirling Hamman thank you also for your support and encouragement.

We all know that umpiring is about successful partnerships and I could find myself with no better partner than Margaret Beaumont, To Margaret I'd like to express my sincere thanks for the way in which she supported me throughout the day. Every game is a learning experience for me and this day was no exception.

To those umpires who have the opportunity and good fortune of standing in this fixture in the future please ensure you grasp it with both hands. Soak up the environment and enjoy every moment of the game and remember that very few umpires will have the opportunity to stand in a game and call "Play" at the SCG!

Appointed Umpires Report – Rep Fixtures 2003-2004 season

26th, 27th & 28th JANUARY 2004
UNIVERSITY OF SYDNEY OVAL NO.1**

**SCORES – Australia 9/450 Declared. Andrew Watkins 172 & Phil Cox 109
Defeated outright England 105 (Phil Cox 5/14 off 8.4) and
344. Umesh Valjee 186 n.o.**

Australia won the toss and batted and at the end of the 1st day were 8/414. Their innings continued on day 2 and Australia declared one hour after the commencement of play at 9/450.

England went in to bat and collapsed for 105 and, forced to follow on were 5/74 at stumps. There was some talk of an early finish for the 3rd day – but cricket is a funny game.

The Third day found the weather if not the players bright and clear when the English Captain Umesh Valjee resumed batting, and bat he did for the entire day and remained 186 n.o. A very inspiring performance given the heat of the day and length of the contest. There was one sticky moment, when Umesh reached his hundred, after kissing the 'Crowns' on his shirt and helmet, he started waving his bat around in the air in big whirling motions with excitement. Arthur Watson the officiating umpire was seen diving for cover as were some of the Australian fieldsmen. Fortunately no injuries were reported.

The test concluded with England's combined total falling just one run short of forcing Australia to bat a second time. With play well into the final hour and the odd thunder clap in the background, England was a little unlucky not to have avoided outright defeat.

Other highlights were when the two umpires were presented before start of play with a copy of '3 Day Test Match – Playing Conditions', they decided to 'play it by ear'. The national anthem signed by a group of school children, a minutes silence for David Hookes, the running between wickets controlled by hand signals, field placing was by signing and the Umpires had to learn an extra signal for 'over', hand above the head in a whirling motion (minus the bat this time).

It was particularly pleasurable to read a report in the Sydney Morning Herald on Saturday, 31st January written by Peter Roebuck, "The Ashes contest where only the Umpire can hear you sledge". Well they didn't sledge and we didn't miss it at all. The game was played as we would like all games to be played –with SPORTSMANSHIP.

I would like to thank Arthur Watson for his guidance, professionalism and sense of humour and also thank the Association for giving me this chance of a lifetime to officiate in a Test Match. In closing, I must mention the thrill of taking the English and Australian caps and holding them in my pocket, that rather mundane act of an umpire was a special one for me.
