<p><u>Decision Making</u></p> <p><u>Excellent</u> – Ruled on a significant number of the decisions in the match and showed excellent judgement at all times. Positive body language throughout.</p> <p><u>Competent</u> – Was perceived to be correct in all decisions deemed as <u>clearly</u> 'Out' or 'Not Out'. Umpire acted confidently was not affected by player pressure & convincingly explained close decisions.</p> <p><u>Inconsistent</u> – Was perceived to have made a number of incorrect decisions on <u>clearly</u> 'Not Out' or 'Out' calls. Umpire showed a lack of consistency across all of the decisions that had to be made. Communicated all necessary information as required.</p> <p><u>Inconsistent</u> – Displayed a lack of control in some instances and seemed unsure or uncomfortable when asked to provide information.
