Stephen Blomfield is the winner of the Shires Umpire of the Year award for season 2012/13.

This is the second time Stephen has won the award having last topped the listing of captain's marks eight years ago back in 2004/05. Stephen won the award with an overall mark of 85.8 out of 100 (The overall Association average mark being 71.2 out of 100). The award this year was a very close race with two other members having an overall mark between 83.0 and Stephen's final mark of 85.8

Stephen's good performances on the field were acknowledged by the Executive Committee with Stephen receiving appointments to the Shires First Grade Grand Finals (only the second time in 12 years he has stood in this match) as well as standing in his 300th Career Match during the Frank Gray Shield Grand Final.



Another commendation Stephen received this season was a comment by one of the First Grade Grand Final captains who in his match assessment wrote this of Stephen -

"Stephen has the complete confidence of the players and just about stands alone amongst Shires umpires in being prepared to take a stand against the antics of "known" players who generally seem to get away with what they want. In my opinion is clearly the best umpire in the competition."

Glen came to the Association after playing cricket for the last 7 or 8 years at Pennant Hills Cricket Club. He is the first ex Pennant Hills player to join the SSCUA since our inception in 2001. Glen contacted the Association and met with the Secretary during the winter as he was unsure if he wanted to pursue an umpiring career. After that discussion Glen decided to give it a crack and did an excellent job in his debut season.

Starting in Third Grade, Glen quickly found himself moving up to Second Grade where he consistently received good feedback from the players and captains (many of whom he had been playing against only 12 months earlier). Glen was further rewarded with a promotion in only his 14th career match when he was elevated to Shires First Grade in Round 11. Umpiring every round of the season Glen was also appointed to a Second Grade Qualifying Final. Disappointingly he was unavailable for

Stephen is worthy of this significant honour. As a player and administrator he made a cogent contribution to the Auburn District Cricket Club of which he is a life member.

The Secretary and Appointments Officer of SSCUA for the past 12 seasons, Stephen has also officiated in 335 matches in various SCA competitions. SSCUA is in the healthy position it is today due to the contribution made to it by Stephen Blomfield.

Stephen's induction as a Legend of Shires took place at the Shires Premiers' Dinner held at Bankstown Sports Club on 17 May 2013 and fellow inductees included Stirling Hamman and Gerard Price. All three share a passion for cricket and for the Shires competition, and all three were so very humbled when responding to their induction.

Stirling Hamman, after 11 years as Chairman of the Shires Sub Committee, has indicated he will be standing down from that role. Stirling assisted with the formation of the SSCUA and has supported the Association in growing to what it is today. Stirling will be missed and his genuine support of umpiring is duly acknowledged. He has been a passionate supporter of the SSCUA. Stirling was a surprised, but deserving inductee to the Legends of Shires.

At the national level NSWCUSA continues to be represented by Gerard Abood, who has a strong connection to Shires cricket as a former player with Burwood Briars. Gerard attended the Shires Premiers' Dinner this year and was delighted to see Briars successful in winning premierships in first, second and third grades.

Gerard was appointed to umpire five Sheffield Shield matches, four matches in the One Day Domestic Cup and five T20 Big Bash League matches. He also umpired the tour match at Manuka Oval, Canberra, between the Cricket Australia Chairman's XI and Sri Lanka.

Gerard continues to go from strength to strength with his umpiring and we look forward to him pushing strongly for elevation to the ICC International Panel of Umpires in the coming years.

NSWCUSA had three umpires selected by Cricket Australia for the National U19 Championships held in Adelaide 7-17 January 2013 with Greg Davidson, Simon Lightbody and Anthony Wilds all putting their best foot forward. Greg and Anthony have subsequently been appointed by Cricket Australia to the U19 One Day International Series in Darwin in June and July featuring Australia, India and New Zealand.

For the second year running Stephen provided outstanding administrative support to NSWCUSA, and to me personally, as I juggled roles of Acting Executive Officer, Education and Development Manager and State Director of Umpiring following the departure of Nick Carson from Cricket NSW on 22 October 2012. The management of Cricket NSW in conjunction with the NSWCUSA Board decided that Nick did not satisfy the conditions of his probationary period.

As such NSWCUSA now has a new management team and structure in place with Sharad Patel being employed as Administration Officer and Troy Penman being deservedly promoted to the position of Administration Manager. The role of State Director of Umpiring and responsibilities for education and development programs rests with the Executive Officer.

In the pursuit of excellence and raising standards it was wonderful to see SSCUA invite NSWCUSA life member Simon Taufel to attend a meeting. Simon lives what he preaches

in all respects. I recently read an interesting quote attributed to him, "It is really important for us to make sure that we stay on top of our game day in day out, and that we are not complacent with our knowledge and our skill base."

Simon is a loss to the ICC Elite Panel as an umpire, but he will work hard as the newly appointed ICC Umpire Performance and Training Manager to support umpires and raise standards through quality coaching and accreditation programs.

As umpires if we give our best in preparation for each match, and give our best when adjudicating on every ball then our stakeholders can't ask for much more. "The meeting of preparation with opportunity generates the offspring we call luck." Tony Robbins.

Season 2013/14 will bring new challenges for umpires with the fifth edition of the 2000 Code of the Laws of Cricket to come into effect on 1 October 2013. At the time of writing there has been no formal correspondence received from either MCC or Cricket Australia about the proposed changes.

In order to provide clarity and consistency to umpires and players when the bowler breaks the stumps at the non-striker's end when delivering the ball, the MCC has decided to make such an act an "unfair delivery" and for it to be called a "No ball".

This is one Law change we know will be introduced if one takes notice of the Lord's web page.

It will be a "no ball" on every occasion and the batsman is protected under Law 24 from six forms of dismissal.

The International Cricket Council adopted this as a standard playing condition effective 1 May 2013. It will be officially included in the Laws of Cricket by MCC on 1 October 2013.

The wording of Law 24.6 is likely to

# Bowler breaking wicket in delivering ball

Either umpire shall call and signal No ball if, other than in an attempt to run out the non-striker under clause 42.11, the bowler breaks the wicket at any time after the ball comes into play and before he completes the stride after the delivery stride.

For the purpose of this clause, the amended definition of delivery stride from Appendix D - Laws of Cricket shall apply:

Delivery Stride is the stride during which the delivery swing is made, whether the ball is released or not. It starts when the bowler's back foot lands for that stride and ends when the front foot lands in the same stride. The stride after the delivery is completed when the next foot lands i.e. when the back foot of the delivery stride lands again.

I conclude my contribution to the SSCUA Annual Report by commending your Association on the 2012/13 season. Your members make a great contribution to the SCA and it is appreciated. The camaraderie that exists between SSCUA members is special. The level of respect the umpires display for each other is fantastic and it is a spirit of teamwork and cooperation that others would benefit from following. There is a genuine rapport among the umpires, and between the umpires and the players in the clubs who value the involvement of SSCUA members in the Shires cricket community. This was evident at the Shires Premiers' Dinner where players and officials spoke with great warmth about the contribution of umpires to Shires cricket.



This season marked the end of our 11th year and in many ways was a duplicate of the previous season in terms of the numbers of active members who stood regularly. I have a strong preference to see new members come from the groups of ex-players as they have not just a great level of skill in decision making they have the innate knowledge of the nuances of the game and the interpersonal relationships that forge teams and clubs together. Some of the Shires clubs have a strong reputation in this regard and one in fact has produced 2 recent Umpires of the Year. From our perspective if you no longer wish to play the view from the stumps is still very rewarding. Overall it appears that the standard of decision making of our members is continuing to increase with experience and the assistance of the materiel provided as support by the training and development team at NSWCUSA.


This season under the guidance of a strong and professionally driven executive our Association has taken a number of steps to further reward our members. Our focus in this regard is for the membership to develop a camaraderie and commitment so that we retain them and help them feel that they are a part of a team not just an organisation.

We purchased white coats for each of the members so that they can have a common and serious image when the weather is a bit chilly. We provided each member with a cap carrying the number of their membership to give a feeling of comradeship. And with the funds from a Federal Government grant we gave each member a fully provisioned First Aid Kit. I must record my personal thanks to our executive member Mark Hughes who provided skilled assistance in compiling the application for funding, something that has been a successful venture in other recent years for us.

This year saw our members extend their coverage into the Masters and Classic competitions a move that was well received by those players and our thanks to the organisation of the Masters Cricket for their liaison in this endeavour. With some help we may be able to recruit some of these players into our ranks.

We also commenced a program of integrating Grade Umpires into the Shires competition in order that they may allow us to cover the maximum number of games, but also to experience the Shires game and its culture to take back to their coterie. The other benefit of this arrangement was that we were able to extend our coverage of games to many of the lower grades that tend to have to umpire themselves, an unsatisfactory experience and one that when they come to the end of the season and meet umpires in the final series does leave them a little uncertain of how to manage the presence of an official umpire.

At our February meeting we were able to pick the brains of the best of the best in a Q & A session with Simon Taufel, an opportunity that many took to improve their own skill sets especially in the area of mental preparation. For most of our members it became clear that the difference between the preparation for a test match and for our games is really just a matter of scale not content, a very good lesson for us all.



Again our members were tested using on-line quizzes especially to focus on playing conditions leading up to the finals weekends. Thanks to Stephen Blomfield for his efforts in this regard.

We were pleased to see that Darren Goodger was appointed as Executive Officer of the NSWCUSA after a difficult year earlier where he wore two hats with distinction. The quality of training generated by the NSWCUSA is as always of the highest standard and well recognised by our members and committee, it is our opinion that there can be no better communicator of complex skills and decision making going around than Darren Goodger, I suspect his modesty will not accept this.

The issue of player behaviour is always a matter for concern and it seemed that this year there was an increase in reports to the commissioner however several of those reports came in one game where the reports generated from the clubs rather than the umpires - in some respect this somewhat inflated the figures. Nonetheless I wish to see a season where Umpires are not placed in positions where they have to report players as these matches generally are an unpleasant experience and in some cases in the past have caused Umpires to retire.

This season our Secretary, Stephen Blomfield, passed a significant milestone in his umpiring career having stood in over 300 matches: the leading performer amongst a strong group of members with over 150 matches under their belts.

Congratulations are extended to the Premiership Sides in the Shires Competition during season 2012/13 – 1st Grade Burwood, 2nd Grade Burwood, 3rd Grade Burwood, 4th Grade Georges River and the Frank Gray Shield was won by Warringah for a record third consecutive season.

We look forward to season 2013/14 with much anticipation.

## SECRETARY'S REPORT



Stephen Blomfield Honorary Secretary 2001 – Current

It is with a great deal of pleasure I present this my twelfth Secretary's Report for this, the Sydney Shires Cricket Umpires Association – Season 2012/13.

For most of us, the last 12 months have generated many big moments in the game of Cricket. The season just gone was described in the cricket media as the year of the exit... whether it by retirement, or ex greats of the game passing away. For me, the death of Tony Grieg a few days after Christmas 2012 was my personal sad moment in 2012/13. Tony and all of those early day Channel 9 commentators did amazing things for Aussie Cricket coverage at the end of the 1970's and beyond.

Tony's passing is yet another reminder to all of us that time marches on and waits for nobody – just like it did for other legends of the game such as Ricky Ponting and Mike Hussey who both exited from the Australian team in late 2012. Thank You Punter, Thank You Mr Cricket, and of course Thank You Greigy, thanks for the memories.

The year 2012 also saw fellow NSWCUSA member Simon Taufel exit from the ICC Elite Umpire Panel. For me this was a great loss to the game as I rate Simon as one of the finest umpires ever to have officiated at that level. Thank You Simon, you were an inspiration to so many of us "grass roots" umpires.

And while others have moved on, let us also not forget those that continued to perform these last 12 months, carrying on making Cricket what it is today...exciting, nail biting, and always riveting viewing. Let's never forget the manner in which the Australian skipper, Michael Clarke, stood up and scored like Bradman during 2012, what an inspiration to everyone who loves this great game. And for those of us with an historical appreciation of our very own Shires Competition, the rise and rise of Mitchell Starc, who started his senior cricket with Auburn Shire Cricket Club as a 15 year old wicket keeper in Shires Fourth Grade! Surely this too would be

a fond memory when reviewing these last 12 months. Yes indeed, the last 12 months have been quite amazing for the game up there at a level that we all look up to, and probably once as youngsters aspired to.

And so from the lofty heights of International Cricket, we now look back on our own season in the Sydney Shires Competition. Although we are fairly well down the ladder when comparing us to the likes of those mentioned above, what we do for Cricket at grass roots level is extremely significant. I applaud each and every member for your ongoing commitment to Cricket Umpiring in the Shires Competition. Can you even imagine what chaos would reign if there was nobody to umpire Shires matches each Saturday. So while I have thanked men with great reputations as mentioned above, I equally thank each member of this Association for your support of the Shires Competition and I hope you continue to do so next season as well.

# THE SSCUA 11th ANNUAL GENERAL MEETING

The season kicked off with the holding of our 11th Annual General Meeting on 18 July 2012 at the Bowlers Club in the City. The attendance of only 30 members (from a membership of 80) was bitterly disappointing for the Executive Committee. Guests on the night were Nick Carson who had recently been employed as the replacement for Darrell Hair in the Executive Officer Role for our parent body - NSW Cricket Umpires and Scorers Association. Other guests were Mike Wood and John Lloyd who represented the Shires competition sub committee.

During the meeting Peter Friend was re-elected unopposed as President of the Association for a record fifth term. Similarly, Stephen Blomfield was re-elected unopposed for his twelfth term as Honorary Secretary. Michael Wheeler stayed on as Treasurer for his third season and Trevor Schokman

was elected as Vice President for the first time. Other committee members elected were Mark Hughes, Jim Shellens, and Ken Buckland. All positions were filled without the requirement of a ballot.

Shortly after the Executive Committee meeting held in mid August, Jim Shellens chose to resign his position from the committee. Ian Bowman was drafted in by the Executive to fill this casual vacancy shortly after Jim's departure.

At our Annual General Meeting, NSWCUSA Executive Officer Nick Carson addressed the members and congratulated the Association on a good season in 2011/12. He also spoke on the production of an exceptional Annual Report that had been collated and published by the SSCUA. He went on to supply some information on the current business within NSWCUSA which included:

- A proposal to better maximise the use of all SCA Umpires across both Grade and Shires Cricket (more on this topic elsewhere in this Secretary's Report)
- NSWCUSA is Celebrating its Centenary Year in 2013 – as many as 34 events/functions that were going to be put on around the state, and also made mention that SSCUA was going to be allocated their own function
- Encouragement for members to attend the Annual Conference.

For Nick Carson, the stay in the Executive Officer role was brief. In October 2012, Cricket NSW and the board of Directors of NSWCUSA asked Nick to leave the role after only about seven months in the position. Two months later Darren Goodger was appointed to the Executive Officer role. This was a proud moment for our Association to have the Executive Officer of NSWCUSA also be a member of the SSCUA. I'm sure we all are glad of this fact and wish Darren well – we all know that Darren will do an amazing job for every member in this state.

#### MASTERS CRICKET

One of the exciting new innovations for the SSCUA in Season 2012/13 was the fact that our Association was approached by the Sydney Masters Cricket Competition and asked if we would take over the allocation of Umpires to that Competition. The previous season had been somewhat of a shambles with a non umpiring background individual in charge of trying to source umpires for each round of matches. Streamlining the Umpire Appointments from our Association was a definite improvement on what had happened the season before. The competition itself is played only on Sundays so this was a great chance for us to give our members more opportunities to umpire.

Prior to the start of the season I sat down with the Competition Chairman, Stirling Hamman and we agreed on some Playing Conditions changes to tighten up a set of rules that had quite a few loopholes in them. I also got the agreement of the competition to increase the umpire match fee from \$110 to \$132. A much fairer payment given that Masters appointments were for just one umpire to stand solo at each game. Hopefully we can get another small increase on the match fee for season 2013/14. In the season just completed we also managed to get a \$25 levy from each of the 32 teams to offset the Association's added administration costs.

They do say it's tough to teach an old dog new tricks and this saying certainly was in play this season. We had a significant number of teething problems during the season with lack of communication from the clubs in making sure the umpires were kept in the loop being a major issue. There were a total of eleven occurrences of a match either being washed out, forfeited or a last minute venue change where both teams got the news but nobody told the umpire. This resulted in an unsatisfactory number

of occurrences where an umpire travelled to a match venue and nobody else showed up. We will continue to work on this issue with the Competition Chairman and the clubs as we move into the new season


On the positive side, a large number of active members embraced the Masters Competition with a total of 28 members umpiring in this competition during the season. Even more pleasing was the fact that we managed to appoint an umpire to every Sunday Masters match during the season without once having to source persons that were not members of our Association. We look forward to once again providing umpires for the Masters Competition in season 2013/14.

#### **MEMBERSHIP**

Season 2012/13 saw a small increase in our membership as compared to Season 2011/12. Thanks for this growth in membership must be attributed to Darren Goodger when guiding potential new umpires through the training courses around Sydney. Darren encouraged a number of new recruits to start their umpiring career in the Shires Competition and for that we once again thank Darren for his unconditional support of this Association.

As at 31 March 2013, which represents the last playing date of the 2012/13 cricket season, we had taken on board a total of 15 new members this season. The total membership count at this time registered 85, an increase of 5 from the same time twelve months earlier. Of these 15 new members, 12 were new applications with another 3 being ex members rejoining. In the losses column a total of 10 members left us with 3 of these allowing their memberships to lapse and another 7 choosing to resign prior to the 31 August 2012 deadline to pay ones annual membership fee.

Of our current 85 members as at 31 March 2013, a total of 34 members managed to umpire in 10 matches or



more in the main Saturday competition during the Preliminary Rounds. This compared to a figure of 33 last season. It is clear that we need more commitment from our members, as well as the need to pick up a significant number of new members to boost this figure. Unless this happens we are always going to be struggling to move forward towards the goal of 100% umpire coverage every Saturday. The number of members who committed to every one of the 14 rounds played in the Saturday competition this season dipped from 15 down to 14. To those 14 members we thank you greatly for showing such commitment to the Shires competition during the season.

Of our current 85 members, 20 were inactive from umpiring in SCA controlled matches this season, an increase of three from season 2011/12. This is a highly disappointing result to think that a QUARTER of this Association's membership choose not to actively umpire. Of the remaining 65 members who did partake in SCA controlled matches, 38 devoted full time umpiring to Shires Cricket on Saturdays, a further seventeen umpired between two and seven Shires matches during the season (these classified as part time members) and the remaining ten devoted themselves as full time umpires in Sydney Grade Cricket. Statistics like this will forever cause us difficulties as we attempt to be in a better position to offer the Shires Competition an even higher level of service than we are currently giving them.

The Burwood Club won the Dave Tribolet Club Championship Trophy for the first time since 2006/07 finishing on 1.385 points. Warringah were a very distant second finishing on 983 points, while North West Sydney took third place with 953 points. Last season's Club Championship winners (Strathfield) finished fourth on 937 points. The Burwood Club had an outstanding season winning the First, Second, and Third Grade Premierships beating Epping, Lane Cove and Strathfield respectively. Burwood's wins in the top three grades had not previously occurred since the early 1980's when the Epping Club achieved this feat.

The result in the top three grades could have been more spectacular with Burwood narrowly missing out on winning a very closely fought Fourth Grade Grand Final where Georges River chased down 195 to win with only 2 wickets in hand.

In the Frank Gray Shield Grand Final, the Warringah Club easily accounted for North West Sydney to claim their third consecutive title in this competition.

The Association this season lost four experienced First Grade Umpires from last season (Three went to Grade Cricket and the fourth took a year off). This loss of depth to our ranks opened up some additional places for Finals Series Appointments. A number of members stepped up to be rewarded with Grand Final appointments to Grades they had not been allocated to in the past.

Stephen Blomfield, for only the second time in his 12 year membership, won a place in the First Grade Grand Final partnering seasoned performer Chris Taylor. This pairing were also allocated the Frank Gray Shield Grand Final. Mike Wheeler (3rd Grade last season) and Aaron Vella (4th Grade last season) jumped into the Second Grade Grand Final. Ian Tabrett umpired his first ever Grand Final in Third Grade partnering Geoff Wheeler who had stood in the Tim Creer Cup (or 5th Grade) last season. Geoff Taylor who had not umpired a Grand Final since 2003 got the gig for the Fourth Grade partnering Spencer Harrison who hadn't seen a Grand Final berth since 2008. What this says is that good members always rise to the top when opportunities arise. Congratulations are extended to all members who got to umpire a Premiership decider.

Ian Tabrett was chosen to umpire the prestigious Grade v Shires Chairman's Trophy match which was played on Sunday 19 February at Bankstown Oval. Ian has filed a separate report on his experience in this match elsewhere in this Annual Report document.

#### AWARDS & MILESTONES

The winner of the three major awards for season 2012/13 were Stephen Blomfield who won the Umpire of the Year Award, Kim Hunter who won the Most Improved Umpire of the Year Award and Glen Stubbings who took out the Rookie Umpire of the Year Award. Kim and Glen won their respective awards quite comfortably from their nearest opponent whereas the Umpire of the Year award was a very close race with four members all being very close to each other based on captains assessment marks. A full report on each member and the award they won is detailed more towards the front section of this Annual Report document (See Page 6 and 7)

During the course of the season a number of members passed significant milestones which were acknowledged with the awarding of each members respective career games polo shirt. Congratulations are extended to the all of the below listed members on reaching these achievements

#### UMPIRE ASSESSMENTS

The third season of the online umpire assessment facility provided via the "My Cricket" website once again gave the Association a quick and easy way to check how captains were assessing our members. The issue of some captains apparently delegating the job of logging in and assessing the umpire to persons who might not have played in the game still continues to exist.

We also have an issue with some captains who clearly give no thought to the process – One particular captain this season marked every umpire in every game exactly the same. That sort of lethargy is simply useless in our endeavour to help improve the standard of umpiring. We also have an unsatisfactory situation that sees a captain not compelled to leave justifying comments in the "comments box" if he marks an umpire poorly.

This is an issue I intend to raise in the winter with NSWCUSA Executive Officer Darren Goodger, hopefully with the assistance of the "My Cricket" team we can get this issue rectified for the upcoming season.

In regards to the data we actually received this summer, it was pleasing to see that every single captain's report

was submitted into the system within a week of the season finishing. A total of 1,566 umpire assessments were captured in the "My Cricket" system this season with the average mark coming in at 71.2 out of 100 (Last season it was 73.4).

The small drop in the average mark I attribute to a number of factors including a larger intake of new members as compared to season 2011/12, as well as a larger number of umpires from the Grade Cricket overflow list participating in Shires Cricket. In both of these examples team captain's are dealing with umpires they have not had any

previous interaction with - and it is common place for some captains to be somewhat harsher when marking these umpires as opposed to longer serving umpires that they are more familiar with.

#### **UMPIRE TRAINING**

Once again we ran an SCA Playing Conditions Quiz during the season using the technology supplied by the Class-Marker Online Quiz Software Team. The software is very cheap to purchase (it only costs us about \$30 to purchase about 50 Quiz attempts). The problem is the time it takes to set up a Quiz. For me to set up the 2012/13 Quiz it took me nearly two weeks spending an hour or two a day on the project. It's very time consuming writing questions and answers and then having to set up all of this data on the Class-Marker programme.

Despite the time it takes to set a Quiz up, I trust that all members find the exercise a worthwhile training tool. The results of the Quiz were at times disappointing and for the Executive it shows that many of our members simply aren't up to scratch with their knowledge of the SCA Playing Conditions. This in itself means we definitely need to continue offering these on line quizzes into the future.

The season also saw us continue with the mentor programme. This season Peter Friend oversaw the project after Jim Shellens decided to move on from this task. This season, Peter Friend, Geoff Wheeler, Ian Tabrett and Mark Hughes kept in touch with our nine rookie umpires that were experiencing umpiring Shires Cricket for the first time. Thanks are extended to all of the mentors for taking on this important role. A separate write up on the mentor programme appears elsewhere in this report.

# COLLABORATING WITH THE NSWCUSA

The start of the season saw a new initiative implemented between SSCUA and NSWCUSA that saw us have access to an additional four umpires each round that would normally be allocated to either 2nd or 3rd Grade in Sydney Grade Cricket. This offer came

at a good time for us as we had lost three experienced 1st Grade members (Darren Goodger, Jim Shellens and Stuart Wood) to Grade cricket, a fourth member in Brett Tribolet who had decided to take a season off umpiring on Saturdays, and Aaron Vella who due to his upcoming wedding didn't commence umpiring until Round 6. It was quite a fair statement to say we were a little thin on 1st Grade experience leading into Round 1.

The idea behind this proposal was to try and maximise use of all umpires across both Associations. For too long many Grade umpires, who were on the surplus list, failed to take up the opportunity to do a Shires match instead. To counteract this issue NSWCUSA were prepared to offer us four Second or Third Panel Grade Umpires to be placed in Shires 1st Grade. The theory was that this would then push up from the Grade surplus list four extra umpires into 5th Grade Cricket.

The concept worked really well in the first half of the season, however it had to be discontinued shortly after the Christmas break as the Grade and Shires draws went sadly out of sync with each other from mid January until the end of the preliminary rounds in early March. Both Darren and I personally thought the concept was a success and we will be hoping that this can be replicated again next season as long as the Grade and Shires draws can stay synchronised for most of the season. With this in mind, both Darren and I will be strongly lobbying the SCA when doing the draws for 2013/14 to keep this issue in mind.

Around the Christmas period we also offered some of our members the chance to stand in a Grade match. This is seen as a great opportunity for members to develop their skills umpiring at different venues, with different clubs and different umpiring partners. This idea is something that we must persist with as it gives all our members the chance to get out of

their comfort zone and experience a different type of cricket. To this end, I look forward next season to once again working with Darren Goodger to ensure further development opportunities are made available to any SSCUA member that wants a one off game in Grade Cricket. As well as the development matches, other opportunities were given to some of our members to stand in AW Green Shield as well as Poidevin Gray Shield matches during the season. Chris Taylor in particular was rewarded with an appointment to stand in the AW Green Shield Qualifying and Semi Finals. Congratulations Chris. I know that those SSCUA members that were offered these extra opportunities were very grateful for the chance to umpire in these competitions. A big thank you to NSWCUSA Executive Officer, Darren Goodger for having the faith in our members to make these added appointments available. We hope this can continue again in 2013/14.

#### FREE BITS AND PIECES


The committee this season was very pleased to be in a position to offer members a significant number of added benefits for their annual subscription fee. We were particularly proud of the manner in which the numbered (gray) membership cap was rolled out. This now forms part of our compulsory uniform when umpires are on the field of play prior to the match starting, or at any other time when

the match is delayed due to adverse weather. We trust all members will please honour this tradition not just for season 2012/13 but in all future seasons to come. If required, members can apply to have an additional cap made up for them by contacting me at anytime. Similarly if you lose your membership cap please contact me to arrange a replacement to be made up for you.

As well as the membership cap we were pleased to provide all active umpires with a white umpires coat to be worn on chilly days. For far too long our members had a huge array of differing clothing items they wore in the cold. The issue of this white coat now gives all members the same item to wear so we don't look like a rabble as has sometimes been the case in the past. The final freebie for the season was funded from a Federal Government Grant that saw each member supplied with a quality first aid kit to be carried around in each members umpiring bag. While we hope that each first aid kit handed out never needs to be used, the fact remains that every active member now has a very useful tool if an emergency situation was to arise.

# PLAYER BEHAVIOUR / CODE OF CONDUCT

I haven't had to raise this issue in our Annual Report for about five years, however this season just gone unfortunately sees me once again having to discuss this topic. A total of

nineteen Shires players had reports lodged against them in season 2012/13. Of those nineteen reports, only thirteen of these were reported by umpires with six being reported by clubs lodging reports against opposing players. The figure of nineteen Code of Conduct reports is the worst result since 2004/05 and something we hope can be turned around next season.

The problems of this season just gone came to a head in February when Peter Friend and I were asked to attend a meeting with the Shires Sub Committee and SCA Committee of Management Chairman, Andrew Falk. After a long discussion it was acknowledged that the changing nature of the competition with many new players not used to the disciplines of serious club cricket was a significant contributing factor in regards to declining player behaviour. Peter and I have committed to the SCA another meeting in the winter to set a plan in motion on how to tackle this issue in season 2013/14. The one message that this Association will continue to communicate is that we will not in any way accept members not reporting incidents that should be reported. To all members I ask that you please be a team player next season and report what needs to be reported. Passing on problems to one of your fellow members during the next round of cricket is quite simply poor form.

#### MEMBERS MEETINGS

Four members meetings occurred in season 2012/13 and for a number of reasons it was felt (with the exception of the AGM) that each meeting held was very keenly attended. The highlight of the year of course was the return to the fully revamped Redfern RSL as our regular meeting place. The venue (now renamed Club Redfern) was once again offered to us free of charge for all our meetings. It really was great to finally be settled back into a regular venue for us to hold our meetings. Thanks

are extended to Club Manager Anthony MacAlpine for his generous offer to allow us to meet at the club at no cost, a far cry from the Bowlers Club that was slugging us a ridiculous amount of money each time we had to use that venue for a meeting. I encourage all members (if you haven't already done so) to please join as a member at Club Redfern. Support the club that supports us. It only costs \$5 a year.

Of the four meetings conducted in season 2012/13 these were the Annual General Meeting held at the York Street Bowlers Club on 18 July 2012, the pre-season meeting at Cricket NSW on 19 September 2012, a general members meeting at Club Redfern on 12 December 2012, and another similar meeting on 21 February 2013. Special thanks are provided to Darren Goodger who was guest speaker at the December meeting, and also to Simon Taufel who graced us with his presence and imparted much wisdom to the membership at the February meeting. It is the intention of the committee to try and get a guest speaker to as many future meetings as possible which we hope will encourage more of you to come along.

As I did last season - I also bring to your attention the low numbers of SSCUA members attending the monthly meetings of our parent Affiliated Association (NSWCUSA) on the First Wednesday of each month. I encourage all members to try and attend these meetings on a more regular basis. These meetings often have invaluable training sessions that I believe many SSCUA members would greatly benefit from.

#### SEASON ANALYSIS

After seeing a large chunk of the previous 2011/12 season heavily affected by rain, it was good to see the end of the La Nina weather patterns that played havoc on our cricket. After a previous season where the ball ruled over the bat it was back to "business"

as usual" in season 2012/13 with dry conditions and bigger scoring being the norm.

As far as umpire appointments are concerned, season 2012-13 saw the following umpire allocations being achieved:


- 100% umpire coverage of all days play in First Grade Shires
- 100% umpire coverage of all days play in Frank Gray Shield Matches
- 100% umpire coverage of all days play in Second Grade Shires
- 92% umpire coverage of all days play in Third Grade Shires
- 41% umpire coverage of all days play in Fourth Grade Shires

There were 665 days of cricket played during the season

562 of these days of play received umpire allocations

#### Total Completion Rate 84.51%

Last Season was 82.99%



The increase of 1.5% in overall umpire coverage from last season is attributed in some part to the increase of umpires made available to Shires from the Grade overflow list, as well as the programme that saw Grade umpires allocated in Shires First Grade in the early part of the season. Without this increased number of surplus umpires from Grade cricket our total coverage would certainly not been as healthy as it is. Thanks are extended to NSWCUSA Executive




It is also noted that the last four seasons have all been around the 82-85% umpire coverage mark. This shows we have been consistently been able to deliver a more than satisfactory supply of umpires to the competition without going one step better to get into the 90%+ coverage (which would see the bulk of 4th Grade games get umpires on a regular basis). Despite the above we still had regular situations last season where Grade umpires on the overflow list refused to accept a Shires appointment in 3rd or 4th Grade and would prefer not to umpire at all rather than stand in Shires. Why people think like this continues to confuse me. Hopefully with time and education this issue will get better. Below are the statistics showing how many surplus Grade Umpires stood in a day of cricket in the Shires Competition during 2012/13 as opposed to the previous eleven seasons.

Each statistic in the above table represents one day of cricket umpired by a Grade umpire in the Shires Competition. If a Grade umpire officiated both days of a 2-Day game then this counts as 2 in the above statistics table

One of the major goals of this Association is to have enough umpires available each week to ensure that all matches in First, Second and Third Grades are covered, with umpires in Fourth Grade being considered as "icing on the cake". This goal requires 42 umpires to be available on any given day of the season. Our coverage





in Third Grade increased this season from 88% in 2011/12 to 92% in 2012/13. A total of 10 Third Grade games didn't get umpires in 2011/12, in the season just completed that figure was only six. "Heading back in the right direction" somebody rightly said to me on Grand Final Day.

We also assisted the Grade competition in November in Round 5 where a number of our members were asked to stand in Sydney Grade Cricket rather than Shires 3rd Grade Games. This has slightly impacted on that 92% Third Grade completion rate. On the flip side we once again fully subscribed in Round 8 (only 28 umpires needed doing 2 x 20/20 matches in a day). Other rounds where we did well were Round 2 with 54 umpires as well as Round 3 with 50 umpires. Our average serviceability for the season


across the 14 preliminary rounds was 44.2 umpires per round which is a very pleasing result.

# RECRUITMENT AND "GETTING INVOLVED"

Recruitment of new umpires leading into season 2013/14 once again needs to be one of our highest priorities.

Our sincere thanks to Darren Goodger who once again referred to Shires cricket a number of new umpires that bolstered our numbers in season 2012/13. Without Darren's ongoing support we will find it increasingly difficult to maintain our service levels to the Shires Competition in seasons to come. This is once again highlighted by the fact that our loyal active on field members are not getting younger.

As some of our members come to the stage where they may consider retiring from umpiring we need to be vigilant in ensuring that a steady of flow of new people come into our competition to umpire. It's a worrying trend for me to see that the average age of our on field umpires has been steadily going up in the last seven seasons to the point where the average age of a member umpiring more than half the rounds has increased from 50.2 years old in 2006/07 to 54.9 years old in season 2012/13. This is illustrated in the below graph -




This season we lost four highly experienced First Grade Umpires when Darren Goodger, Jim Shellens, and Stuart Wood moved across to Grade Cricket. We also lost Brett Tribolet for the season due to family commitments. Next season we see Aaron Vella, one of our younger umpires move onto Grade Cricket. As well as this we may lose others.

The issue as to who is going to step up and fill these voids in experience can only be addressed if we continue to recruit new umpires into our Association. I have said it before, and sadly feel it necessary to say it again, that I do NOT believe that the majority of our members are doing enough to

try and recruit new members to our Association. If you care about the future of this Association then everyone needs to take a bigger role in regards to recruitment. We have staggered at around the 80 mark in regards to our membership for a few years now. Our goal is to one day be in a position to have 100 or more persons holding membership of our Association at any given time. But to achieve this everybody has to do more in regards to recruitment.

#### SOCIAL GATHERINGS

Members were given a number of opportunities during the year just passed to come together away from on field activities and meetings to enjoy each others company. In particular there were three events held this year which our members attended. On 13 April 2013 our parent body NSWCUSA held its annual dinner at Bankstown Sports Club. Being the centenary year the Executive Committee all attended this event organising a separate table. As well as this about another 10 members also attended sitting on various tables around the room. The highlight of the night for this Association was when our President, Peter Friend, was acknowledged for the hard work he has done for the SSCUA over the last twelve seasons as a member, and the last five as the President. Peter at



this event was awarded the prestigious EW Wykes Association Medal. This was a fitting reward for Peter and his commitment to Shires Cricket. Other SSCUA members acknowledged on the evening were Mark Hughes (100 game certificate), Ken Buckland (200 game certificate), and Ian Bowman (10 year membership badge). Of note was that two ex members of our Association were presented with awards on the night with Dean Martin winning the Grade Panel 3 Award, and Ben Treloar winning the George Borwick Award which is the top honour each season within the NSWCUSA.

On Saturday May 4 the Association put on an end of season social function which was kindly hosted by our Vice President, Trevor Schokman. This was



a fully paid for BBQ late lunch which saw a total of around 30 people attend. I know I speak on behalf of the Association when I sincerely thank Trevor for putting up his home and conducting the preparation and cooking of the food.

On Friday May 17 a number of our members attended the end of season Shires Presentation Dinner. This year the event was put on by the Shires Competition Sub Committee rather than the SCA, and the venue was changed from the traditional spot at Darling Harbour to Bankstown Sports Club. A good night was had by all with each of the premiership teams being presented with the competition trophies. This is an event the SSCUA strongly supports and we hope that all members will consider attending next season.

# THANK YOU'S AND CONCLUSION SUMMARY

To conclude, I'd like to now take some time to thank and acknowledge a range of other people who have all made a contribution to Shires Cricket in season 2012/13. Without all of these people making a contribution then we would all probably be doing something quite different on Saturdays and Sundays during the summer. Thank you to everybody below, your contributions certainly do not go unappreciated.

Thank you to our President Peter **Friend** who in season 2012/13 completed his fifth season in the Chair. Sadly though Peter has decided not to seek re-election next season as he has medium term plans to retire and move out of Sydney. Peter has been an amazing President for the SSCUA over the last five seasons and has been a tower of strength for me. I will miss him greatly. I wish Peter well in the future. I know he will still be here for the start of season 2013/14 as an active umpire. I'm also hoping his plans to move allow him to umpire as long as possible before he has to move 🖫 on. Selfishly, I have my fingers crossed that he might umpire the majority (if not all) of next season.

To **Mike Wheeler** our Treasurer I offer many thanks. Mike has managed our finances with much gusto and enthusiasm. His record keeping is outstanding and the manor in which he continually provides the committee projections regarding our future finances is much appreciated as it assists the committee greatly to determine what we can and can't afford to spend. Thanks again for a great season Mike, your efforts are applauded

To lan Bowman, Ken Buckland, Mark Hughes and Trevor Schokman who make up the rest of the management team, I wish to offer my thanks for your support and contributions this season. This committee ran very smoothly during the season and we all got along famously. Thank you for your contribution which was very much appreciated by me.

Special thanks to **George Richards** who offered up his services as a match observer during the season assisting our new (and not so new) members passing on wisdom and advice based on his years of on field experience. Further thanks are extended to George for his photography skills taking photos which make the presentation of this Annual Report something that this Association is very proud of. In regards to match observers - We are now in search of a second match observer in 2013/14 to add to our team. If you are a non active member and want to watch and report on other members please let us know. Match observers in 2012/13 received an \$80 a day payment from the SCA. So your time for taking on an observer role is financially covered.

To **Steve Murphy** who runs and hosts our website at his own expense many thanks are extended. Steve after many years of being in the background showed up to a few meetings this season. We hope all our members will

get to meet in the future the member behind our great website. I'm even hopeful that one day Steve will return to active umpiring!

We really do now have an Annual report that is the envy of many other Clubs and Association's. Every member should be exceptionally proud of this report and basically we have lan to thank for this. ## TREASURER'S REPORT



Mike Wheeler Honorary Treasurer July 2010 – Current

The goal of the Executive Committee for the 2012/2013 season was that the finance of the SSCUA during the season should provide a year of consolidation for our Association, and, that's precisely as it eventuated.

The financial year commenced on 1 May 2012 with a medium sized surplus that was carried forward from the previous financial year. This springboard into the 2012/2013 season enabled the committee to pursue it's well documented intention of returning value added benefits to the members.

The season also witnessed, for the first time, the Association taking control of umpire appointments for Masters and Classics cricket with the benefit to members of increasing Association revenue by way of a \$25 per side levy that each of the 32 teams in this competition paid to the SSCUA. This levy was called for to assist our Association cover administration costs associated with the added work of administering umpires for the Masters and Classics competitions.

With this in mind, in it's eleventh year, this would be the first season that the Committee elected to revise the procedure for fund raising by way of income derived from sales of tickets for the annual raffle. Members were offered alternative options designed to reduce the overall financial outlay required for membership fees and raffle book procurement. Ultimately, the new procedure resulted the Association returning approximately \$800 to the members.

Revenue streams for the season were further enhanced with the payment of a Government Grant specifically targeting volunteer organisations. The criteria for spending the grant were clearly detailed and, in this respect the Association provided, by way of a gift, to each active member, an accredited first aid kit to keep in their match day bag. The balance of the grant accounted for new office equipment for the association's use to replace

some existing outdated and somewhat inefficient assets.

Another new initiative funded this season was the introduction of a commemorative medal for all umpires upon the appointment to their debut 1st Grade match. This financial year, sufficient stock of medals was purchased to service the Association's requirements for up to the next 5 or 6 seasons. The additional cost of personalised engraving will be budgeted on an annual basis in the future.

This season also saw the Committee's approval to fund the procurement of new merchandise products, such as field shirts, milestone shirts, caps, weather jackets and the like, all with a view to enhancing our stock levels for the future. A full Association asset register is available for inspection.

In line with approved policy, members attending Association meetings benefited with the provision of free post meeting food and drinks at the AGM as well as the December and February meetings. Members also approved the concept of a post season function which was held at Trevor Schokman's home – Those who attended this fully catered event enjoyed a great day together with food and drink supplied at no cost to members.

The Treasurer's strategy for providing a cash surplus into next season is to avoid the need to procure an overdraft/loan arrangement to cover the immediate close/early season work in progress expenditure pending the future receipt of membership subscriptions.

As is Association policy, the financial balance sheets are supplied to members only as a separate insert to our annual report.

First Season as Mentor Programme Coordinator This was the fifth year of the mentoring programme and my first in the role of programme co-ordinator. It was rewarding to see that a large number of graduates from earlier years umpired in the Finals series this season.

All up, we had 15 new members join our ranks this season. Three of these were ex members who decided to re-join the SSCUA, another three were new members that already had experience umpiring in other competitions in the past, and the other nine were "rookies" that were brand new to umpiring. It was these nine "rookies" that the mentor programme focussed on this season and a short summary of those nine members and how they progressed through their first season with us appears further down in this report.

Taking over from Jim Shellens in this role was a challenge as his contribution in earlier years was enormous. Geoff Wheeler and Mark Hughes were again of immense help with Ian Tabrett joining the mentoring group. However I must confess we did not quite achieve as much as was provided in earlier years.

Staying in touch regularly with phone calls prior to and after matches was a key to helping our new members adapt to umpiring regularly. George Richards also performed the role of match observer as often as he was able. As part of the match observer process we often concentrated matches that George was to observe at venues where the "rookies" were allocated to. Thank you to George for giving up his Saturdays to keep an eye on our up and coming members.

There is no doubt that many of our new members did struggle as reflected in their Captain's marks. There are reasons that don't always reflect actual performance. Captains are not familiar with new members and in many cases new Captains are unaware of how to score Umpires correctly. It is also the case that we like to expose our newest members to lower grade

matches before throwing them up the ladder. In these games players and Captains have not been seeing umpires regularly and judge them based on how they or their counterparts have made decisions in games where no umpires are present. Naturally quality decision making is a bit different to not having a good understanding or the interpretation and application of the laws. We are confident that all of the new umpires will continue to improve with time and experience so that they retain and improve the standard of decision making in our ranks.

I would also like to thank all those umpires who gave their time, patience and experience to help the new umpires through their first few days, and launch them on their careers. It is important that new umpires receive help from people who can remember what it was like on their first day. After over 200 games I must admit that it sometimes difficult to visualise the nerves and challenges that new umpires face and being involved with mentoring is a good way to recall those early days and help plan a path that will help all of our new member also reach that milestone number of games.

We intend to continue with the mentoring programme again next season with the assistance of the quality materiel available from the NSWCUSA Education and Training Division. Thanks to Darren Goodger for all of his assistance throughout the season past.

Below is a short summary of each of our nine 'rookies' that started umpiring in the Shires Competition during season 2012/13. The Associations thanks each of these members for choosing to umpire in the Shires Competition and we hope all of these members choose to come back for another season in the summer of 2013/14 –

#### BEREND DU PLESSIS

Berend umpired part of the season while playing the other part. This restricted him to a total of 7 matches in which he umpired. He received solid feedback in most matches he officiated and after starting the season in Third Grade managed to gain a number of Second Grade appointments post Christmas. We hope to see Berend back next year as he has the potential to make it to First Grade in his second season of umpiring.

#### SIMON FAIRLIE

Simon joined the Association hoping to umpire but decided he wanted to continue playing for the Macquarie Uni Club on Saturdays. This restricted opportunities we were we able to supply Simon however by seasons end he had umpired 2 rounds of Saturday Shires Cricket as well as standing in 9 Sunday Masters rounds. Once Simon has finished his playing career and commits to Saturday umpiring he will no doubt become a very good member for the Association.

#### JUDE FONSEKA

Jude came to the Association as he has a son that plays at Epping Cricket Club. Jude was a reliable member that stood in 12 of the 14 Rounds played during the season. Suffered a bit early in the season as most new umpires do as he came to grips with umpiring the Laws while trying to also grasp the Playing Conditions as well as learning on the job about umpiring technique. After his debut year we expect next season will see umpiring become a lot easier for Jude.

#### BAYA7FD HOSSAIN

Bayazed had an interrupted season umpiring about 10 matches, however a number of these he could only umpire on one day of a two day fixture which for a first year umpire was not ideal. Because of all this stopping and starting I don't think he got a lot of momentum during the season. Hopefully next year will be able to commit to more cricket and be available for both days of most of the two day rounds.

#### YATIN PRABHAKAR

Yatin showed a rare keenness and willingness to learn in his debut season. Umpired a total of 11 matches in Third Grade and would have got a look into Second Grade at the end of the season but the game he was allocated to, was washed out. Yatin needs to learn to speak slower when talking to captains and players, so that his message gets heard. With his debut season behind him, should blossom into a good umpire in 2013/14

Ashafur umpired 11 out of the first 12 Rounds including earning a promotion from Third Grade to Second Grade for a number of rounds. He hopes to be back in Sydney for the start of next season and we look forward to seeing him come back to rejoin us on the field

It was Chinese New Year on Sunday February 19th and we helped celebrate by holding the Annual Grade versus Shires Match at a superbly prepared Bankstown Memorial Oval. My partner on the day was experienced 1st Grade Shires/Grade umpire Ken Buckland and this was the first time I had the opportunity to umpire with Ken.

Our umpire's room within the main pavilion was almost large enough to hold our Shire's Annual General Meeting and included our own shower and a fridge fully stocked with many different types of beverages. So it was a good start to the day for Ken and I.

When we were going through the gate on the way out to the wicket, you couldn't help to notice the large number of ground and support staff all of whom were working hard to make sure that all was perfect for a great day's cricket. The outfield was like a green carpet and was blemish-free and the wicket was very flat and had the same strawwhite consistency to it that you see when watching international matches. Had the Channel 9 commentators been here, they would have been predicting an innings score of between 250-300 runs.

The Shire's Captain was Don Nash (North-West) with Phil Hangyasi (Fairfield-Liverpool) as the Captain of the Grade team. Don won the toss and had no hesitation in deciding to bat. It was interesting to hear the concerned rumblings from some of the officials following Don's decision to bat. They were worried that the Grade bowlers would quickly go through the Shire's batting line-up and that there would be an early finish to the game. It became apparent that the Shire's side was quickly blowing out in the betting, but someone forgot to tell the Shire's team

Michael McKeough (Epping) and Scott Hutchinson (Lindfield) opened the batting for Shires and after a cautious start an early wicket saw Cosi Beadle (Pennant Hills) come to the crease. Scoring was slow as the two opening bowlers from Grade, Tim Ley (Sydney University) and Nick McLachlan (Manly), were bowling at a good pace and stump to stump. The opening bowlers received wonderful support from ground fielding of the Grade side which was of a very high standard with none better than Nathan Sowter (Blacktown) in the covers.

A steady second wicket partnership was building but the loss of two relatively quick wickets saw the score at 3-58 with Captain Don Nash coming to the crease to join Cosi Beadle. Don batted in his normal style and significantly increased the scoring rate by hitting the ball hard and often over the heads of the inner fieldsmen. During this partnership, Cosi also kept the scoreboard ticking over with some glorious drives on both sides of the wicket

With the score on 104, the Shires team lost their 4th wicket when Don Nash was caught at deep mid-off. Cosi Beadle, who was continuing to score freely, was joined by Sanketh Gitte (Auburn) who kept turning the strike over to Beadle by accumulating a number of singles. When Beadle was dismissed for an excellent 57. the platform had been set for a respectable Shire's score. Gitte (22) and a late hard-hitting 17 not out by Dan Lenehan (Roseville), saw the Shire's total finish at 9-201 after the 50 overs. The pick of the Grade bowlers was Phil Hangasi (Fairfield-Liverpool) who captured three wickets, with Michael Edwards (Manly) and Nathan Sowter (Blacktown) who picked up two wickets each.

After an enjoyable lunch we were back on the field for the Grade innings. The general consensus at lunch was that the Shire's side had done well to post a score of 201, but it wouldn't be enough to beat the Grade team.

Grade innings started disastrously. with Joe Scarcella (Lane Cove) picking up a wicket with the second ball of the innings. After another quick wicket, this time to Marc Seymour (Burwood) and Grade were 2-12 with the two batsmen at the crease being Justin Avendano (North Sydney) and Jason Hughes (Mosman). A partnership of nearly 50 steadied the ship for Grade but a lovely lain Cowan (Auburn) delivery saw Hughes heading back to the pavilion. Avendano continued to score freely with some elegant front-foot drives. The score had reached 3-88 and it was anyone's game.

However, from this point on, the Grade innings collapsed and 7 wickets fell for the addition of only 54 more runs and they were all out for 142.

The collapse was started by one of the best balls of the day (delivered by Marc Seymour) which got through the dangerous Avendano's defence. All of the Shire's bowlers supported their Captain (and team) and bowled well. Willis Blunt (Roseville), Iain Cowan (Auburn) and Marc Seymour picked two wickets each, with Joe Scarcella (Lane Cove) gaining the important first wicket. A late 4-over cameo performance by Dan Lenehan (Roseville) quickly wrapped up the tail with Lenehan capturing the last three wickets.

This was the first win by Shires in nearly 10 years and only the fourth time they had won in the history of the Chairman's Trophy matches. In a close decision, the 'Player of the Day' was Cosi Beadle for his innings of 57 which helped build the Shires innings to an eventual winning total.

Both teams' thanks went to all those at Bankstown Memorial Oval and to Roy Formica (Cricket NSW) for all their efforts and hospitality which together went to make the day such an enjoyable one.

## 1ST GRADE GRAND FINAL

Blacktown Olympic Park 1 30th and 31st March 2013

After having lost the last two Grand Finals to Strathfield in 2010/11 and Lane Cove in 2011/12, Burwood Briars Cricket Club under the captaincy of Jason Holley was determined to make the saying "Third Time Lucky" come true this season. After winning the minor premiership Burwood went through to this Grand Final fairly comfortably with an easy outright victory against Roseville in the Qualifying Final and a similarly easy outright win against Lane Cove in the Semi Final. The other participant in this match (Epping Cricket Club) didn't reach the Grand Final so easily. After running fourth at the end of the round matches they had a tough win against Auburn in the Qualifying Final and then stumbled over the line in the Semi Final against Lindfield barely defending an imposing total of 380 scored over the first 130 overs of that Semi Final match.

Upon arrival at Blacktown Olympic Park on Day 1 (Easter Saturday) we were greeted with the shock news that the covers had not been removed all day on Good Friday. We were confronted with a wet wicket with the covers sweating and leaving significant damp

spots on the pitch. Disappointingly for the show piece event of Shires Cricket, the start was delayed by 60 minutes. At the toss Epping captain Ian Wheatley called incorrectly and Burwood captain Jason Holley quickly chose to insert the opposition.

The Epping innings started slowly and cautiously with runs at a premium. The wet spots on the pitch saw balls moving off the seam a little more pronounced than normal. Whilst no batsman during the first session got out as a result of the pitch it certainly made stroke play very difficult indeed.

The tight bowling however did reap rewards with wickets in the first session falling regularly. At lunch Epping were 5/70 off 38 overs after a gruelling 135 minute session of sustained bowling from the Minor Premiers. None of the top order managed to get started with a top score of 21 by Pascal De l'Eppine being the best of the five dismissed batsmen prior to lunch

After lunch with the sun out and baking the wicket it was much more noticeable that the wet spots from the morning were starting to disappear making batting somewhat easier. A sixth wicket with the score on 91 saw

Steve Sharp and Steve Commons come together to form what was developing into a solid partnership. However just as things were starting to make solid progress for Epping with a partnership of 43, Sharp holed out for 17. The score was now 7 for 134

Another turning point of the match occurred shortly after with Commons taking off for a suicidal single to Steve Davis at backward square leg while on 49. This resulted in his partner Joe Barnes comfortably run out at the keepers end for a score of just 4. With 7 for 146 becoming 8 for 146 things were not looking at bright for the Epping lads. The arrival of the new ball just an over after the tea break made all the difference as the final two Epping wickets fell within 8 balls with the final score being 157 off a total of 81.2 overs. Best for Epping was Steve Commons with 56 while for the fielding side Mark Seymour took 4/36 off 21 overs and wicket keeper Andrew Jalalaty taking 5 catches with the gloves.

Burwood began the chase for 158 with a minimum of 19 overs left in the days play. The goal was to blunt out the new ball and try and get to stumps with a minimal amount of damage. Despite some solid moments Burwood lost 2 wickets in the evening session and went to stumps at 2 for 43 with Ben Eves taking the wickets of both Burwood openers.

The second morning started shakily for the Burwood side. Regular wickets fell in the first session including the two big guns of Mark Seymour and the skipper Jason Holley. At 5 for 69 the game was certainly up for grabs. A steady partnership between Squire and Blaszczyk got the score to 89 before Squire swung loosely at the first ball after drinks to be caught by the keeper. From 6 for 89 the scored progressed to 6 for 111 which ended up being the lunch score.

Coming out after lunch the equation was tantalising – 47 runs needed with 4 wickets in hand. The loss of Seb Blaszczyk with the score on 121 gave

Epping some hope of a win however Burwood number 9 Daniel McLaughlan quickly put paid to that idea and despite an 8th wicket falling at 144 he played an aggressive knock of 33 off 37 balls that saw Burwood home with 2 wickets to spare in the 72nd over.

For Epping the stand out bowler was Anthony Boorer who completed figures of 5/37 off 22 overs including 11 maidens. Worthy of note is that 15 of his conceded 37 runs came in his last two overs with McLaughlan swinging hard at anything he could.

If not for McLaughlan's batting at the end to steer Burwood home to a win it was felt that Boorer would definitely had been the man of the match. In the end that award fell to McLaughlan who had also heavily contributed with the ball on the Saturday taking 2/39 off 23

And so Burwood were proclaimed Premiers for the season, their first Premiership in this Grade since 2005/06.

On a bright sunny morning at North Epping Oval Lane Cove won the toss and captain Sam Mantarro elected to bat first

The pitch and outfield prepared by the host club, Epping, looked to be almost perfect, and that's the way it played throughout the two days of play. Congratulations to the groundsmen.

During a somewhat slow days batting Lane Cove were at the crease for 65 overs scoring just 134 runs.

Lane Cove got off to a poor start, losing 2 wickets with just 2 runs on the board. Wickets then fell regularly with the Burwood attack intent on not allowing any meaningful partnerships to flourish. The innings itself, fell apart when Lane Cove lost their last 6 wickets for just 17 runs. The standout batsman for Lane Cove was Owen Fisher who scored 68 runs from 144 balls faced, including 10 fours.

Such was the intensity of the Burwood Briars bowling and fielding, clinically managed by Captain Cameron Beames, that no other Lane Cove batsman managed to score more than 20 and only two other Lane Cove batsman, Pirenu Nirmalendran and Ian Davidson managed to score a boundary.

Burwood Briars bowled and fielded as a team, each of the 5 bowlers summoned took wickets and each returned Grand Final quality miserly figures, typified by Peter Catalovski who bowled 18 overs, 10 of which were maidens snaring 3 wickets for just 27 runs. Sanjiv Khalkho bowled well during his 5 overs for a return of 3 wickets for a scrooge like 6 runs including 2 maidens. The bowling attack was ably reinforced by Brad Scully who took 2 for 31, Will Service 1 for 37 and Wayne Grimson 1 for 20

The intensity of Burwood's bowling, fielding and overall captaincy in the field can be measured by the fact that in a total of 65 overs bowled, 28 of them were maiden overs. Captain Cameron Beames ably supported his accurate bowling attack by taking 4 catches fielding at slip.

Following the conclusion of the Lane Cove innings Burwood were challenged with the task of gaining an advantage during the tricky 39 overs remaining in the first day's play.

The Briars top order remained steady, intent on building for a first innings lead and saw themselves through to day two with the loss of just 3 wickets.

Burwood Briars have again defended the 3rd Grade Premiership to retain the J. B. Hollander Cup at Bruce Purser Oval. This makes three titles in a row for Burwood following their wins in both 2010/11 and 2011/12. Their opponents in this year's match were a gallant Strathfield side.

The two top teams following the preliminary rounds competed in the Grand Final as Burwood were clear Minor Premiers with Strathfield finishing in second place. In the semifinals Burwood secured a hard-fought win over the tough North West side and Strathfield won a rain affected match over Warringah where the first day was completely washed out.

When the teams arrived at Bruce purser Oval, they were confronted with a perfect day to play cricket. The sun was shining, there was a slight breeze and the temperature was in the low to mid 20's.

The wicket and outfield had been freshly cut and the grounds-woman Simone had done an excellent job in preparing a very flat wicket with just the right amount of grass on it for this Grand Final. The outfield was green and lush and whilst in immaculate

condition, the grass was longer than most grounds which was going to make scoring boundaries a more difficult task than normal.

About 20 minutes before the toss something unusual and freakish happened to a Burwood player during the warm-up session. One of his own players accidentally spiked him deeply in the Achilles region of one of his heels. It wasn't felt safe to move the player and an ambulance was called and came onto the field and eventually took him away to hospital. It was learnt later that whilst a number of stiches were required to fix the gash, however, thankfully, no other serious injuries were sustained. This injury meant that one of Burwood's star players was unable to play in the Grand Final.

Both captains, David Spears from Strathfield and Gareth Robson from Burwood enthusiastically examined the pitch again just prior to the toss. The toss was won by Strathfield with David Spears deciding that his team would bat first. With the wisdom of hindsight, it could be argued that the fate of the Grand Final was decided in the first few overs of the game. A maiden to Adam O'Keefe in the first

over set the tone for the match with the bat rarely ever dominating the ball. Jack Kovacic was Burwood's other opening bowler and he had the Briars quickly on top by rattling the stumps in his first and second overs, to have both Strathfield openers back in the dressing-room and the score was 2/2.

A brilliant catch in the gully by Smith gave Kovacic his third wicket and had Strathfield reeling at 3/7. The slow outfield and tight bowling made it tough to score runs. O'Keefe then chimed in with Burwood's 4th wicket (also bowled) and at the first drinks break, Strathfield were 4/26 and 15 overs had been bowled.

Joe Bolster and Phil Blakely-Kidd were at the crease for Strathfield and with good defensive batting techniques were slowly ticking the scoreboard over and surviving against an accurate bowling attack. No further wickets fell between drinks and lunch with the lunchtime score being 4/45. The partnership was broken by Kovacic in the hour after lunch, but not before 50 valuable runs was added to the Strathfield score. The fall of this wicket heralded a batting collapse with the last 5 wickets only yielding 10 more runs. Nardo with two wickets and another three to Kovacic were the destroyers. Strathfield were all out for 74 in 43.3 overs with Jack Kovacic achieving the

excellent figures of 7/24 off 15 overs. He was well supported by O'Keefe who finished with 1-9 off 14 overs.

Burwood started their innings in a very watchful and deliberate manner. Thomas and Kennedy were taking no chances and were slowly trying to squeeze Strathfield out of the game. Chasing a modest total of 74 the openers had taken Burwood to 0/31 when David Spears produced two lovely balls to dismiss both openers. Wylie chipped in with a wicket with the last ball before tea and Burwood found themselves 3/43 going into the break.

Spears and Soni launched a twin spin attack at Burwood with 22 overs being bowled in the first hour after tea and the batsmen were defending grimly. Burwood's batsmen of Robson and Smith kept holding the accurate Strathfield attack out and they eventually passed Strathfield's score with the loss of only 3 wickets. The relief of passing Strathfield's total took its toll with Soni's spin capturing two wickets and Spears getting one. Burwood were 6/89 at the end of Day 1 and with 104 overs left in the match, it was still anyone's game.

The first hour of Day 2 would go a long way in determining who would win this match. As it turned out, the Burwood batsmen Nardo and Andrews held out the relentless Strathfield attack until

The Georges River's bowlers then seemed to get their line and length right with Burwood motoring at the end of the 4th over at 0/21 to be 1/21 by the 6th over, 2/30 by the 10th over, 3/33 by the 11th over and 4/58 after 30 over at lunch. A good session for the underdogs.

No sooner had play resumed Burwood found themselves 5/67 and in deep trouble if they were to secure a grand final victory. Panta and Kirkham came together and began taking the aerial route to the boundary giving the bowling side numerous opportunities to snare another wicket, but alas Panta rode his luck and was dropped on no fewer that four occasions. By drinks Burwood had progressed to 5/117 off 51 overs and looked to be on the road to a good score. Panta was out just after drinks for an entertaining 59, being out to a rank long hop LBW that should have been put away for a boundary, 6/125 off 53 overs. No sooner was Panta out another wicket fell with the score on 7/130 off 56 overs. Stevens had
